Counsel for the personal representative (or if none, then the self-represented personal representative) is ordered to return unless all required documents have been filed at least 5 court days before the review hearing date and the matter is vacated or recommended off-calendar. Order for Probate not to be signed until an Agreement to Appear and Comply (L-1450) for the review hearing signed by counsel or the self-represented petitioner has been filed.

Either the Petition for Final Distribution OR a Report on Status of Administration MUST be filed. You are ordered to return at the review hearing unless all required documents are filed at least 5 court days before and the matter is either vacated or recommended off calendar. Attorneys, please note that if you are relieved as counsel before this review hearing, you are still subject to the order to return and must ensure that someone appears at this hearing. Your Order for Probate will not be signed until an Agreement to Appear and Comply at the review hearing has been filed. Be sure to read the form carefully before signing it.
